INDEMNITY AND RELEASE

Rogaining is an outdoor activity which involves risk of personal injury and property damage. Participants must take care to avoid injuries from falls, especially in wet or dark conditions. Other risks may arise because of the nature and type of terrain, weather conditions, or in connection with animals or other elements in the environment.

The ACT Rogaining Association Inc (ACTRA) requires any person participating in its rogaining events to indemnify and release ACTRA*, and the owner and occupier of any land* on which an event is held, from any liability for loss, personal injury or property damage arising from ACTRA events. This requirement applies irrespective of whether ACTRA or the owner or occupier of land may have been negligent.

ACTRA expects all participants to carry safety-related equipment such as lights, a space blanket, a first aid kit, weather proof and warm clothing, and other devices to limit the risks inherent in rogaining activity.

Mandatory equipment requirements are detailed in the Final Instructions for each event.

If any parent or legal guardian of a **person under the age of 18 years on the day of the event** allows or encourages the younger person to participate in rogaining activity, then that parent or legal guardian is hereby advised that ACTRA cannot accept any liability for injury or loss caused to the participant or their property. The parent or legal guardian acknowledges that by signing this indemnity or by permitting the younger person to participate, the parent or legal guardian accepts complete responsibility for any injury or loss caused to the participant or their property.

* **ACTRA, and an owner or occupier of land, includes the respective employees, servants or agents of such entities.**

I acknowledge that:

- *I have read and understood the information above*
- *The sport of rogaining involves considerable risk*
- *I enter this ACTRA event at my own risk*
- *ACTRA and the owners or occupiers of land used in the event accept no responsibility for any loss, personal injury or property damage, however occurring, suffered by me in connection with the event.*

I agree:

- *I will not claim or institute legal proceedings for any loss, personal injury or property damage directly or indirectly arising from attending or participating in the event, against ACTRA or against any owner or occupier of land used in the event*
- *I indemnify ACTRA and any owner or occupier of land used in the event for any loss, personal injury or property damage I may suffer arising directly or indirectly from attending or participating in the event*
- *This indemnity may be pleaded by ACTRA and any owner or occupier of land used in the event as a complete defence to any legal proceedings or any right I may claim against one or more of them*
